# **ANDOVER RUGBY FOOTBALL CLUB**

## **CODES OF CONDUCT**

1. All members of Andover Rugby Football Club (ARFC) are required to play and support the playing of rugby union football (the game) in accordance with the spirit of the game and in accordance with the laws of the game, and the Code of Rugby as defined by the Rugby Football Union (the RFU).
2. Members should ensure that whilst playing the game and when supporting ARFC that they do not behave in an unsporting manner or in a manner that is likely to blemish the reputation of ARFC or to bring the game into disrepute. In particular, members should not:
  - Insult opponents;
  - Behave abusively or offensively towards the referee, the touch judges or opposition supporters;
  - Feign injury;
  - Take property belonging to opponents or to an opposing club;
  - Publicly criticise the referee;
  - Play under the influence of alcohol or illegal drugs;
  - Behave in a racist manner;
  - Abuse or insult officers or employees of ARFC;
  - Deliberately behave in a manner which is likely to cause offence to the public, including whilst traveling to or from a fixture.
3. Members are reminded that ARFC and its officers could be held responsible by the Hampshire RFU and/or the RFU for the misconduct of its members.
4. ARFC will discourage from selection, any player who repeatedly infringes this code, and in respect of any such player or member, may hold an inquiry into any alleged breach of discipline. Depending on the outcome of an inquiry, a player or member may have their membership suspended or indeed be expelled from the club.
5. Members are further reminded that they are accountable to ARFC for their behaviour. The Executive Committee of ARFC may hold an inquiry into any alleged breach of this code and will discourage from selection any player who infringes this code. Any member found to be in breach of this code may have their membership of ARFC suspended or terminated by the Executive Committee.
